character of sand from when dry to when wet fascinates children. It additionally trains their tactile sense and fine motor skills. The Sand Box 8 trains the understanding of material character and nature phenomena: that sand in the sun is hot, that sand in the rain is shapeable. That sand in the sun is dry and light-weight, and wet sand is cold and heavy.

These are important understandings that contribute to the child's package of life skills that help the child understand the surrounding world. So sand play aids the child's sensory-motor skills and cognition and adds an understanding of the world.

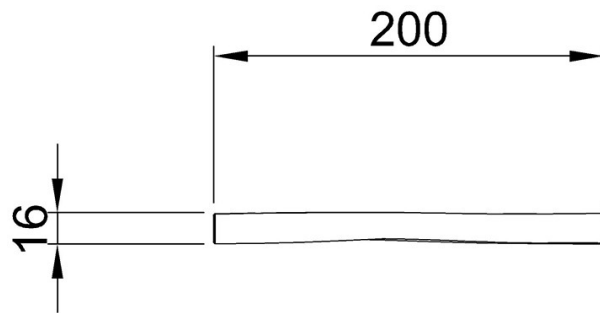

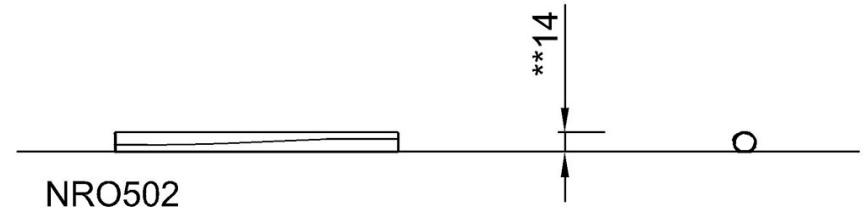
