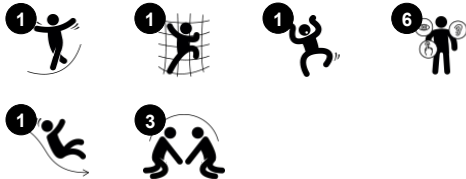

modal perception enables reading. The playhouse also offers a space for social play. The windows encourage children to seek out their friends from on top of the tower. The sturdy desk on the side of the structure is an additional place for meetings. Sliding supports posture and balance, important skills for young children as they grow, and great fun for active

physical play.

Theme

Window

Social-Emotional: invites interaction between sides and cooperative play.

Physical: supports physical strength and cross-body coordination, which impacts coordination of the right and left part of brain.

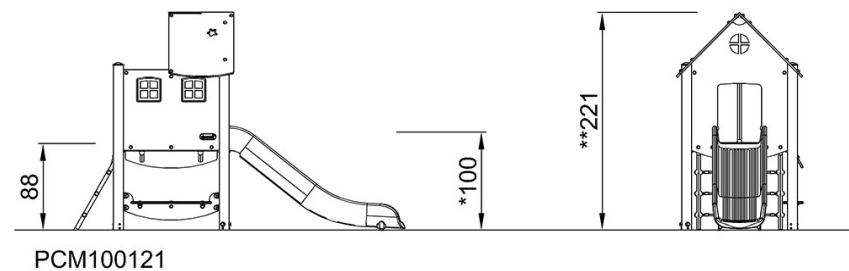
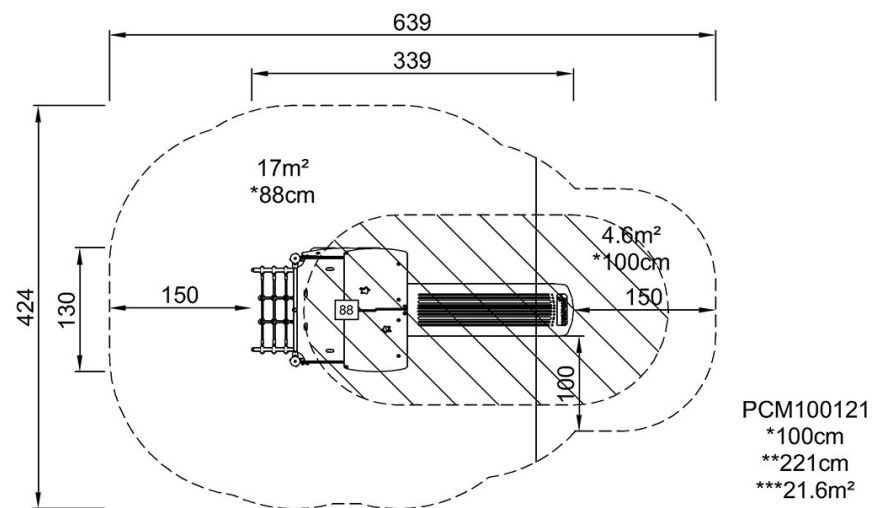
