## Theme

## Foot support

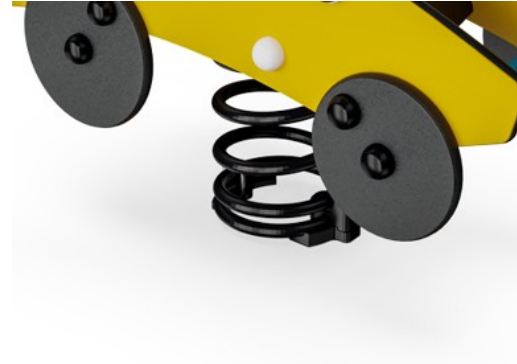
**Physical:** the footrest supports intensive rocking, which stimulates the senses of balance and space, fundamental for managing the world securely.
