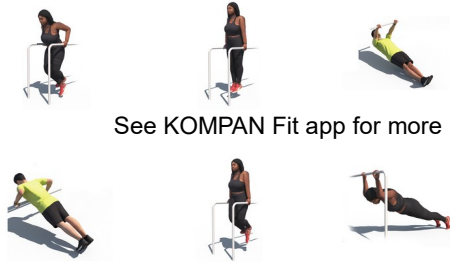

do dips. They can start with leaning push-ups against the bar and can later move on to actual dips, which can initially be made easier by resting the feet on the additional bars. All parts where users will place their hands are covered with Polyurea coating which is highly durable against wear and tear, offers isolation and simultaneously gives users an outstanding grip

during their workout.

The Polyurea Coating, used on all grips, is highly durable against wear and tear, offers isolation and simultaneously gives users an outstanding grip during their workout.



The big instruction signs are made of a 8mm polycarbonate sheets with clear instructions printed directly on the panels. The polycarbonate is extremely strong and provides a vandalism proof construction.



The product offers two sets of parallel bars  $\varnothing 48.3 \times 4\text{mm}$ , three different heights (104, 114 and 124cm) and four lower side bars  $\varnothing 33.7 \times 3\text{mm}$ . Combined these 6 bars offer a wide variety of training options.

All Steel components are made from carbon steel, with a hot-dip galvanised surface according to ISO1461, and a powder coating corrosion class C3 according to ISO12944-2. Lead content for surfaces is below 90ppm, and below 100ppm for base material.



For ensuring the integrity of the main frame, the orange coloured main posts are made of  $\varnothing 101.6 \times 3\text{mm}$  steel posts, which are hot dip galvanised and powder coated Orange (RAL2010). The supportive posts receive the same surface treatment and are made of  $\varnothing 76.1 \times 3.6\text{mm}$  steel tubes, powder coated grey (RAL7012).



All KOMPAN fitness products are compliant with the ASTM F3101 & EN16630 Outdoor Fitness Standards. Load tests are performed as a static test by adding dynamic factors as well as safety factors to the specified load of 78kg per user. A product intended for 1 user is loaded with 420kg.

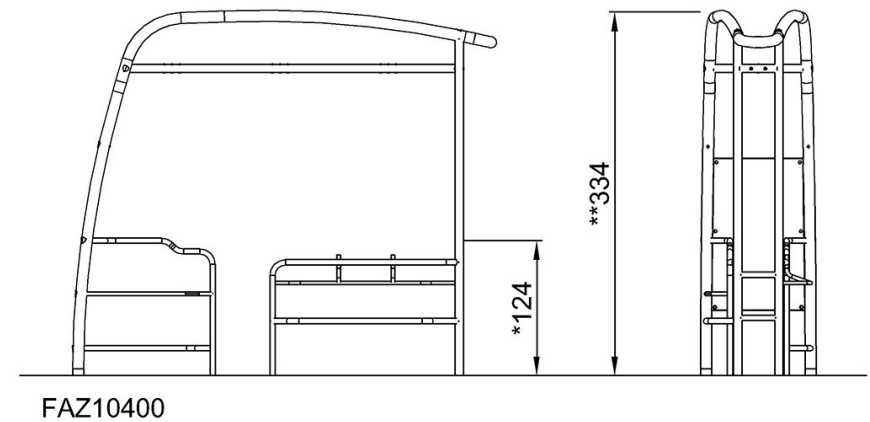
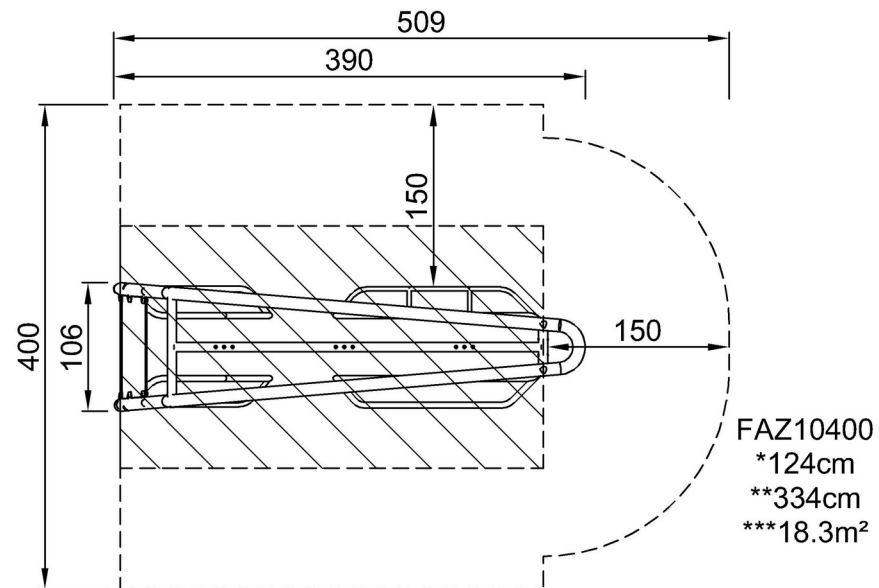
