



The support frame is  $\varnothing 48.3 \times 4$ mm, carbon steel, with a hot-dip galvanised surface according to ISO1461, and a powder coating corrosion class C3 according to ISO12944-2. Lead content for surfaces are below 90ppm.



The Polyurea Coating, used on all grips, is highly durable against wear and tear, offers isolation and simultaneously gives users an outstanding grip during their workout.



A 5 mm hot-dip galvanised carbon steel plate must be moulded inside the SBR to offer optimal stability and optimize the mounting of the step to the frame.




