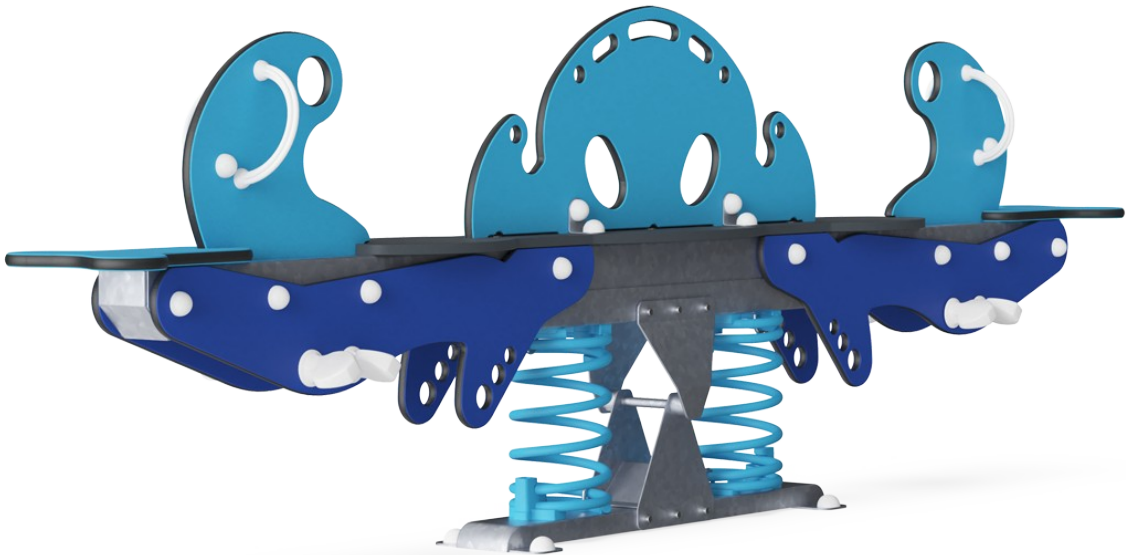

The Octopus seesaw motivates children to join in play, rocking together. The cartoonish design attracts children. The sturdy hand and foot support allow for mild and wild rocking. The spring base makes it possible for different ages, even adults and children, to rock together. The Octopus head in the middle supports seating and holding tight while being

rocked, sensing the movement of the others. This allows for more socializing and more children. There is room enough for a caregiver, too. The seats at the end are big enough for older children as well as adults. The fun thrill of rocking, individually or in pairs or groups, will make children play for longer. Rocking on the Octopus seesaw trains the children's muscles

and motor skills, e.g. balance and coordination. The Octopus supports development of social-emotional skills like cooperation, consideration and taking turns.

Theme

Cognitive: suggests a theme and supports dramatic play, which stimulates language and communication skills.



Rocking together

Social-Emotional: the possibility of rocking together develops cooperation skills and consideration of others when rocking.



Foot support

Physical: a good footrest supports intense rocking. Rocking stimulates the senses of balance and space that are fundamental in managing the world securely. Intense rocking also develops coordination and muscle strength.



Rocking spring

Physical: response to movement increases spatial awareness and sense of balance. These are fundamental motor skills that help the child's ability to sit still on a chair which takes a good sense of balance. **Cognitive:** trains the understanding of cause and effect: when I move my body, the spring responds with movement.

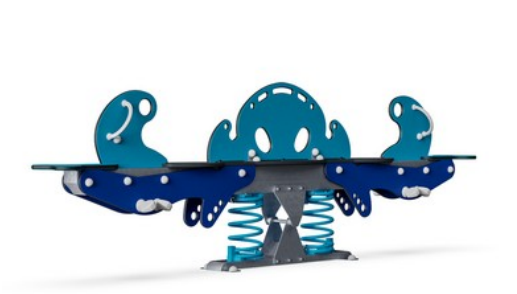


Handhold

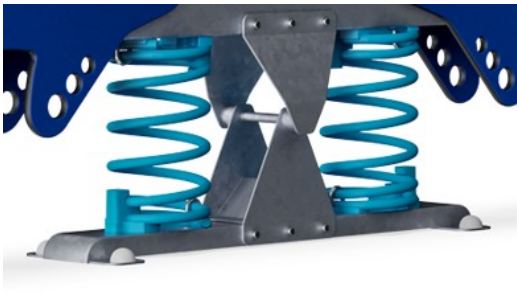
Physical: the vertical handgrips ensure a firm grip at different heights, necessary for rocking intensely. This trains hand and arm muscles.

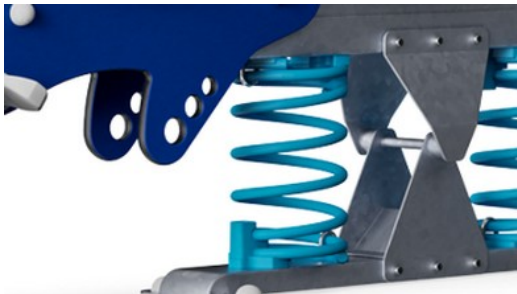

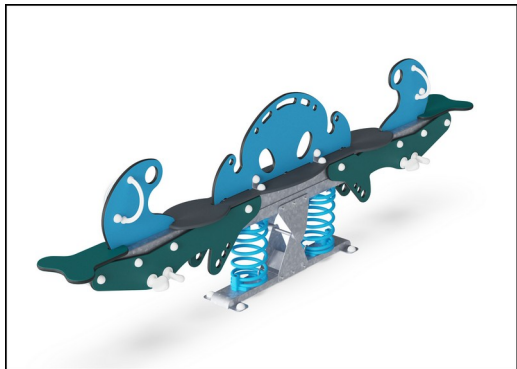

Handholds and footrests are made of injection moulded high quality nylon (PA6). PA6 has good wearing and impact strength.



The steel support posts are hot dip galvanized inside and outside with lead free zinc. The galvanization has excellent corrosion resistance in outside environments and requires low maintenance.

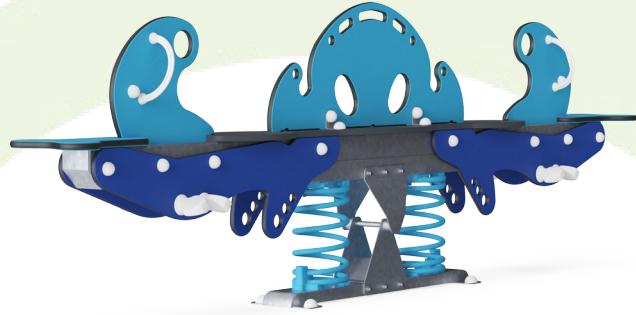

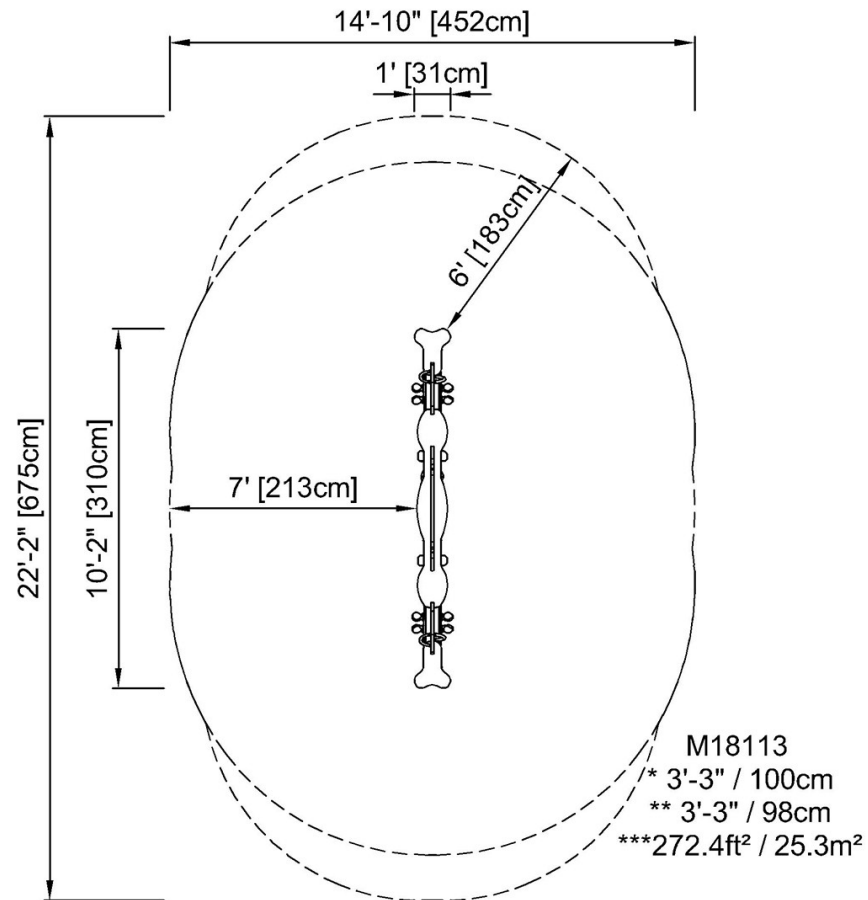

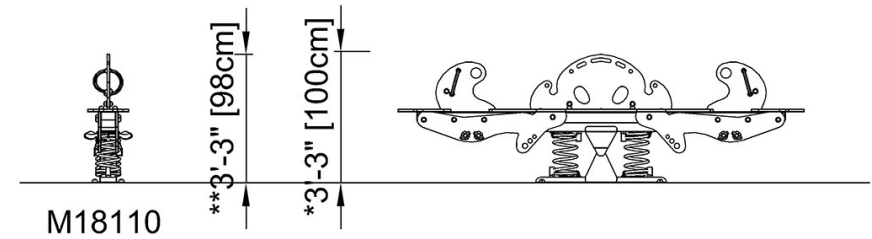
