## Turbo challenge

**身体素质** : upper body muscles are trained when hanging. Agility, proprioception and coordination are trained when spinning from one ring to the next. Spatial awareness and sense of balance are trained by the rotating motion. **社交情感** : the sections of each of the spinners allow for more children hanging in arms or knees, cooperating. This trains empathy and turn-taking skills.

连接器是由压铸铝，适合户外环境和高频率使用。连接的螺丝是不锈钢的，并由锌垫圈保护。



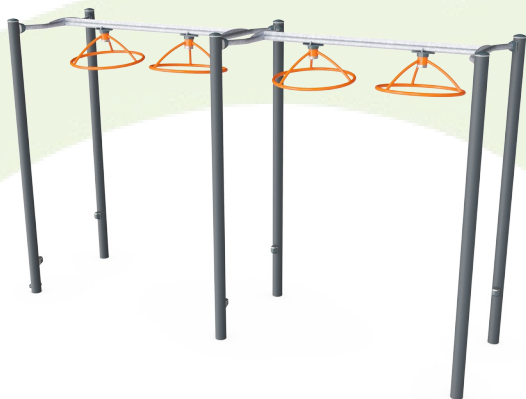

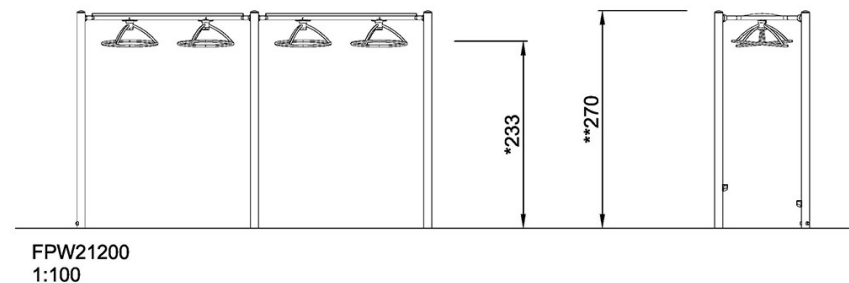
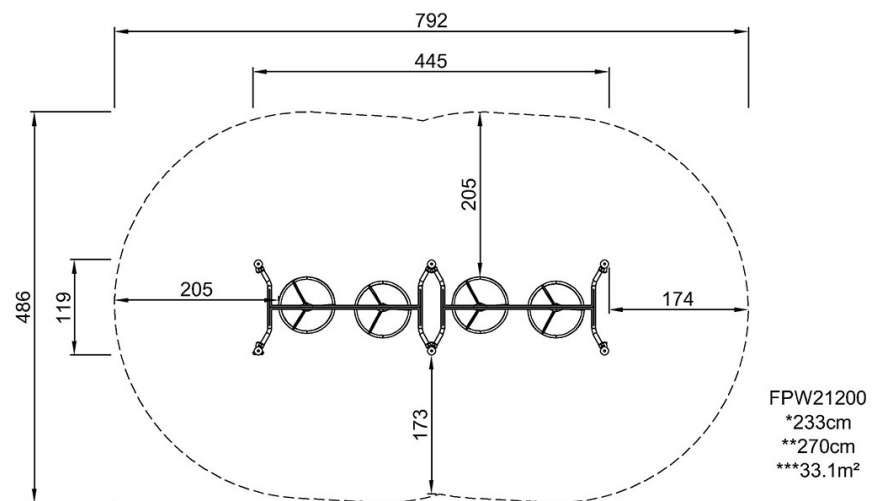
