What child doesn't like flying through the air on a super long cableway? And with this double cableway, children and adults can race their friends and family zipping down the line! This cableway can also be adjusted to have a ride between 19m and 25m long, and is designed to go on a flat ground (so ramps or mound are needed at the start). Combine the thrill of the

ride with the look and feel of natural Robinia timber, which provides an organic structure that can either blend into or stand out from your surrounds. Children can touch and feel the timber while playing, observing how nature inspiration interacts with the built environment

PUR covered rope

Physical: firm grip when spinning and hanging from arms. Arm muscles developed when held tight.



Long line

Physical: the lengthy glide through the air adds to the thrill and trains spatial awareness, trunk stability and upper-body muscles. All this helps support the child's physical self esteem, making e.g. positive risk taking easier.



Dino seat

Physical: the three divisions and chains of the seat provide efficient handholds for both standing and seated swinging. **Social-Emotional:** the possibility of children swinging together, legs hanging down, trains cooperation, sequencing and turn-taking when swinging.



Double zipline

Social-Emotional: the possibility to glide with a companion or have friendly competitions supports turn taking and cooperation skills. **Cognitive:** the speed may differ between the two zip lines. Figuring out the reason behind this (weight, speed, force etc.) trains logical thinking.

All organic Robinia products by KOMPAN are made of Robinia wood which is sourced from sustainable plantation farms. On request it can be supplied as FSC® Certified (FSC® C004450).



The steel surfaces are hot-dip galvanised inside and outside with lead-free zinc. The galvanisation has excellent corrosion resistance in outside environments and requires low maintenance.



The specially designed seat is made from a stainless-steel insert covered with a soft layer of PUR rubber. The seat is impact tested to comply with global playground standards, and the rope has an ergonomic handhold of a 100cm long moulded on PUR rubber handle.

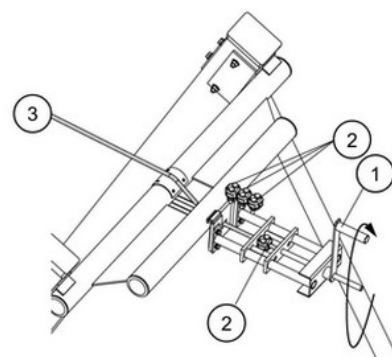

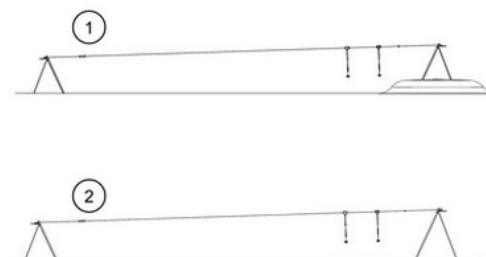

The high-quality steel cable with a diameter of 12mm is designed for heavy usage of the cableway for many years. The starting point is indicated by a knob. At the stop point, there is a uniquely designed spring device, ensuring a softer stop of the puller.



The steel cable three is tensioned by a specially designed device. By turning the handle, the steel cable can be tensioned safely. After tensioning the cable is locked by three clamps two. The tensioning device can also be used for adjustment during annual inspections.



KOMPAN cableways are available for flat or natural sloped surroundings and for surface or in-ground installation. Further, the cableways can be supplied with one or two cables for children to ride together in friendly competition.

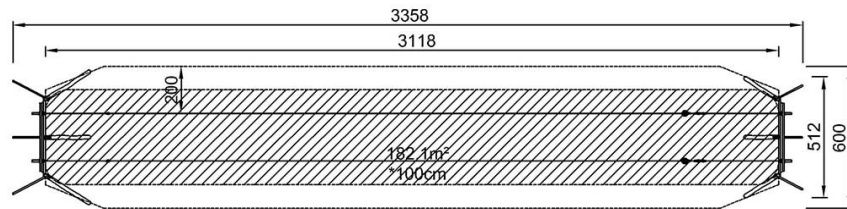

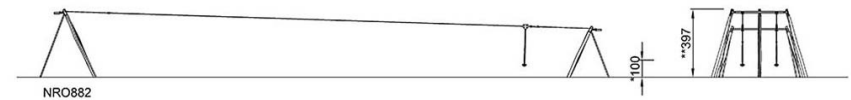
