

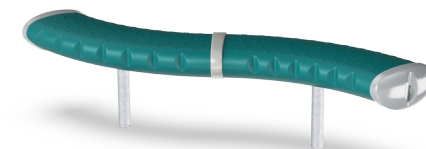
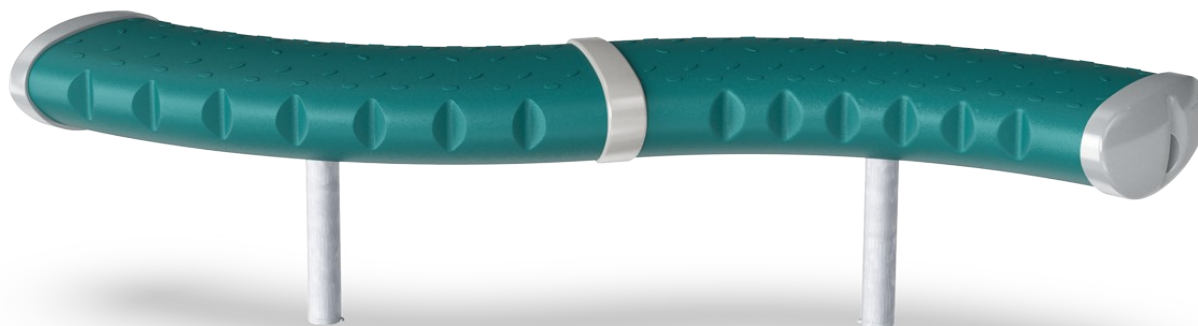

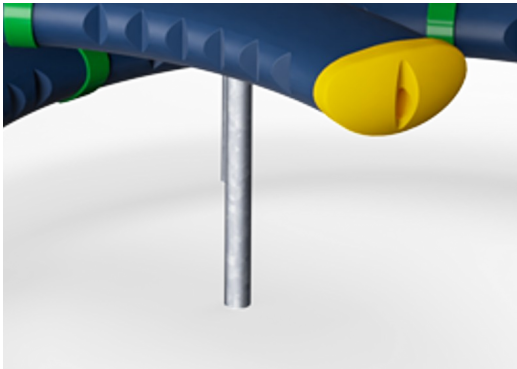


The curved benches can be installed at different heights and next to each other to create a tribune. The benches are a splendid meeting point to socialise with friends and look at sports activities at the same time.

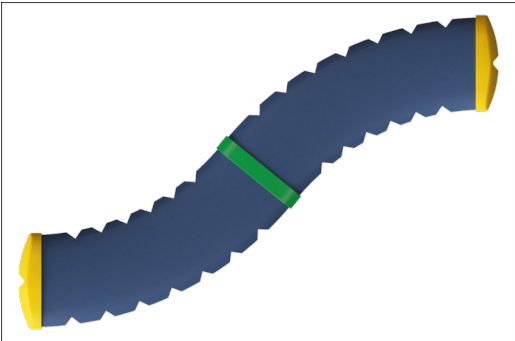
