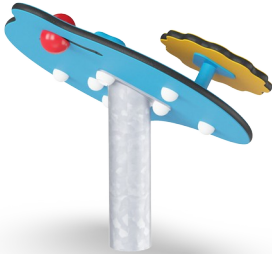

Social-Emotional: cooperation, turn-taking, sharing. **Cognitive:** suggests a theme and supports dramatic play, which stimulates languages skills.

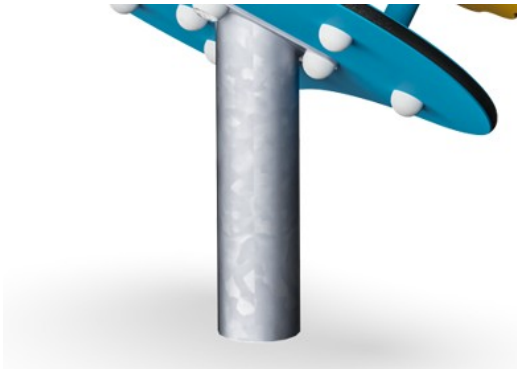


Turning wheel

Panels of 19mm EcoCore™. EcoCore™ is a highly durable, eco friendly material, which is not only recyclable after use, but also consists of material produced from +95% recycled post consumer material from food packing waste.

The steel surfaces are hot dip galvanised inside and outside with lead free zinc. The galvanisation has excellent corrosion resistance in outside environments and requires low maintenance.

Play spheres are made of PP. PP has good wearing and impact resistance.

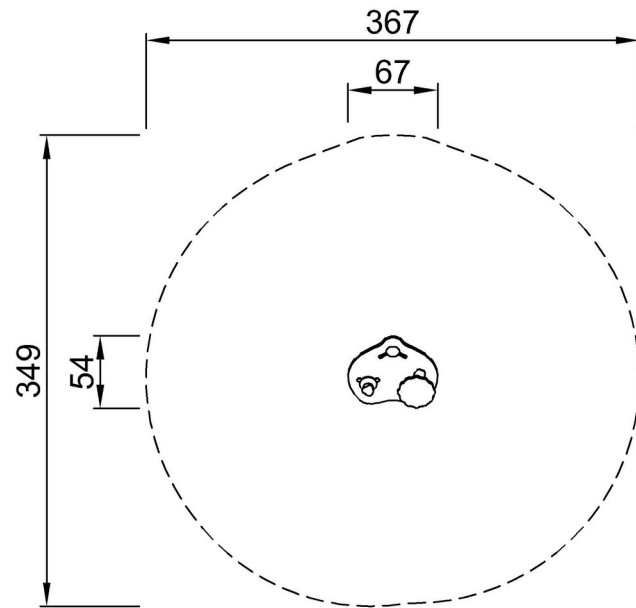
