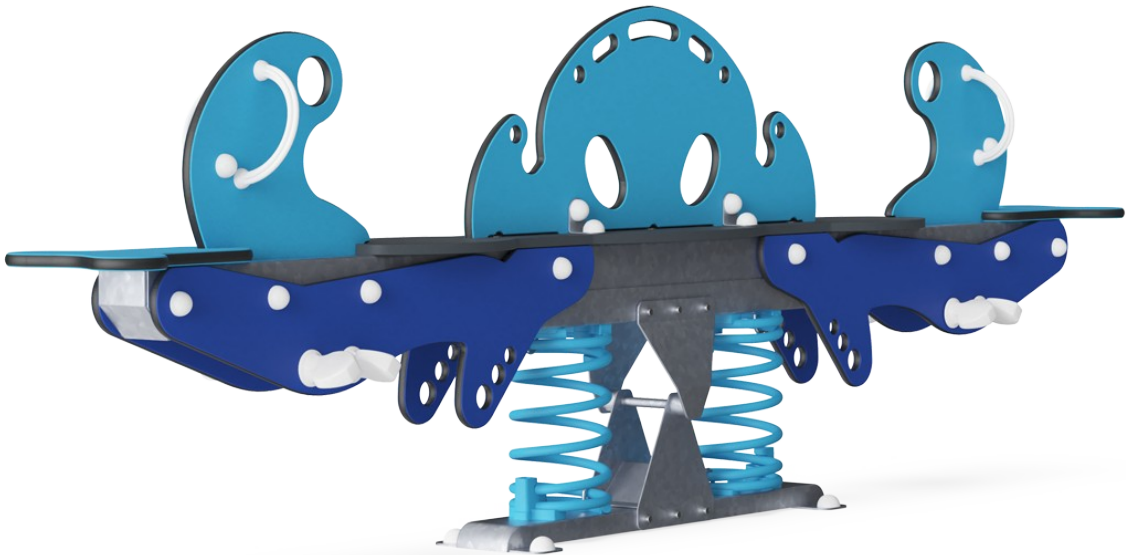

The Octopus seesaw helps to motivate children to join in play, so they are rocking together. The cartoonish design attracts children and makes them want to play. The sturdy hand and foot supports allow for mild or wild rocking, depending on the child's energy level. The spring base makes it possible for a range of ages to rock together. The Octopus head in the

middle supports an upright seat and for holding tight while being rocked. This allows for more socialising and more children. There is room enough for a care giver, too. The seats at the end are big enough for older children as well as adults. The fun thrill of rocking, individually or in pairs or groups, will make children want to play for longer. Rocking on the Octopus seesaw

trains the children's muscles and motor skills, e.g. balance and coordination and supports the development of social-emotional skills, e.g. cooperation, consideration and turn-taking.

Theme

Cognitive: suggests a theme and supports dramatic play, which stimulates language and communication skills.



Rocking together

Social-Emotional: the possibility of rocking two together trains cooperation skills and consideration of others.



Foot support

Physical: the footrest supports intensive rocking, simulating the senses of balance and space and supports coordination and muscle strength.



Rocking spring

Physical: response to movements adds to spatial awareness and sense of balance which are fundamental motor skills.
Cognitive: trains the understanding of cause and effect: when I move my body, the spring responds with movement.



Handhold

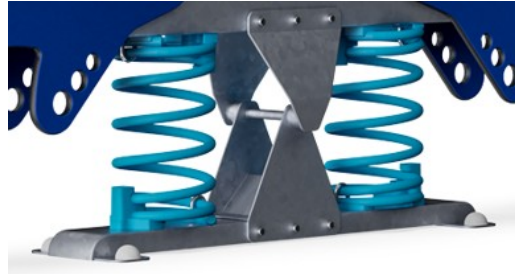
Physical: opens more hold positions and ensures good grip, necessary for rocking intensely which trains hand and arm muscles.
