

## Funnel

**Social-Emotional:** trains cooperation and turn-taking as children put materials into the funnel. **Cognitive:** the passing of materials through funnels supports the children's logical thinking and for younger children the understanding of object permanence: that materials don't vanish but run through at the other end.



## Sand desk with bowl and sieve

**Social-Emotional:** children can gather and store materials, cooperate and take a break together. **Creative:** sand can be shifted through the sieve, for understanding of cause and effect and object permanence.



## Sand shovel

**Physical:** develops dexterity and upper body muscles. **Cognitive:** understanding of object permanence, emptying and filling scoop.



## Lower platform

**Physical:** climbing up, jumping down develops muscle and motor skills such as coordination, which are important in navigating your body securely through the world. **Social-Emotional:** children can sit and talk together. The step helps children who need extra height to maneuver the tap and water channel.




