The middle bar accommodates friends who want to be rocked and the differently shaped handholds allow for more hand hold heights. The calibrated rocking element provides a smooth rocking motion. Rocking is not only fun,

it stimulates physical and socio-emotional skills. The Csaw's movements help to develop spatial awareness and a sense of balance. These are fundamental motor skills that help the child move about confidently. The cooperation and turn-taking in seesawing build important socio-emotional skills such as turn-taking and empathy. These are important for

building an understanding of human interaction that will support the child's ability to build friendships for life.

Rocking movement

Physical: response to movements adds to spatial awareness and sense of balance which are fundamental motor skills.

Cognitive: trains the understanding of cause and effect: when I move my body, the spring responds with movement.



Handhold

Physical: the possibility to hold on tight enables intense rocking. This trains the hand and arm muscles.



Rocking together

Social-Emotional: the possibility of rocking two together trains cooperation skills and consideration of others.



The steel surfaces are hot-dip galvanised inside and outside with lead-free zinc. The galvanisation has excellent corrosion resistance in outside environments and requires low maintenance.



The seats are made from 19mm EcoCore™ which is a highly durable, eco-friendly material, that is not only recyclable after use, but also consists of a core produced from 100% recycled material.



The teardrop handle shape and diameter has been designed to be the optimal fitting for older children. Finishing has been achieved with special thermoplastic polyurethane (TPU) rubber surface, making it an appealing surface to touch.



The rocking movement over axis is made by heavy duty scaled ROSTA torsion spring element. The ROSTA element operates quietly and requires low maintenance.

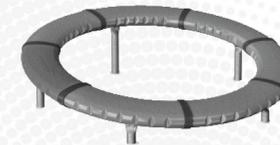






* Max fall height | ** Total height | *** Safety surfacing area
