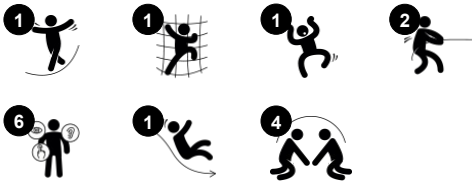

## Platform

**Social-Emotional:** courage, self-confidence, consideration and turn-taking are built when children share the platform.



## Slide

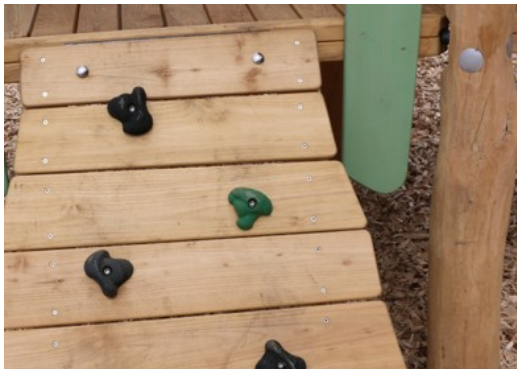
