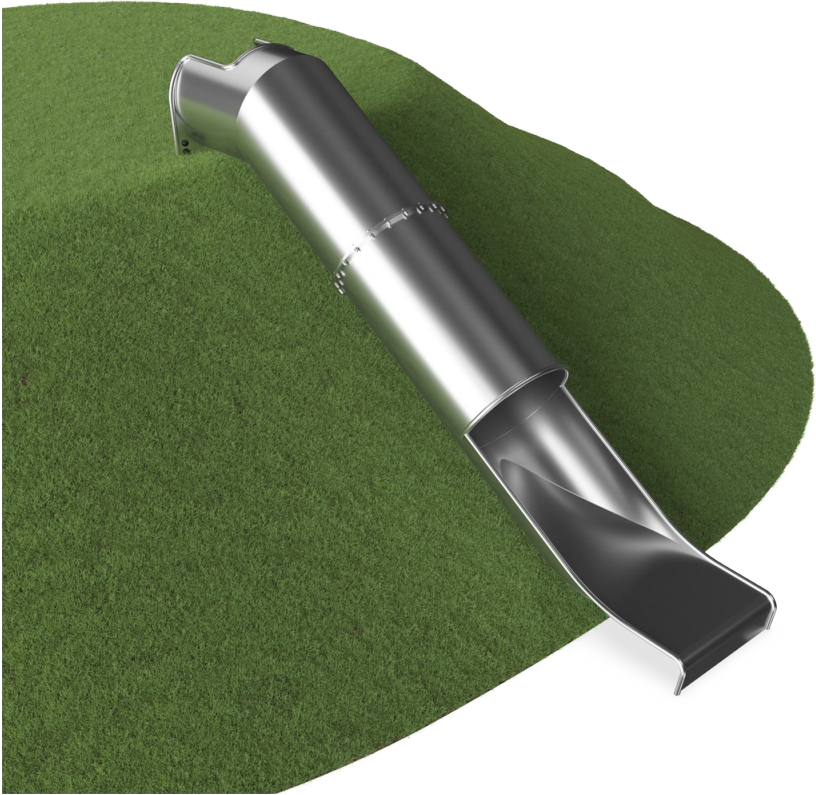

when entering. The width of the slide invites rides with friends. The slide mouth is extra long to add a feeling of security.



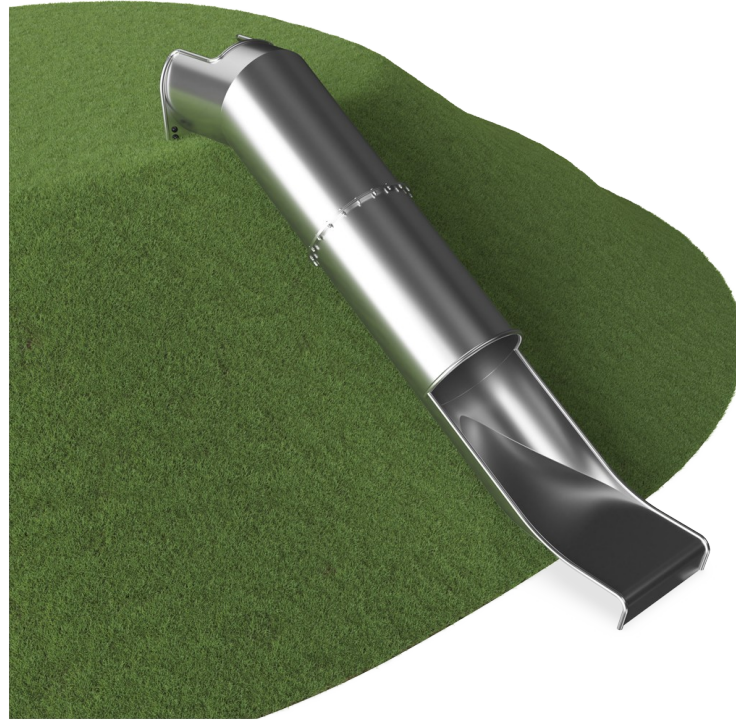

Catering to different terrains, the embankment slides are available in 9 lengths from 1 - 3m.

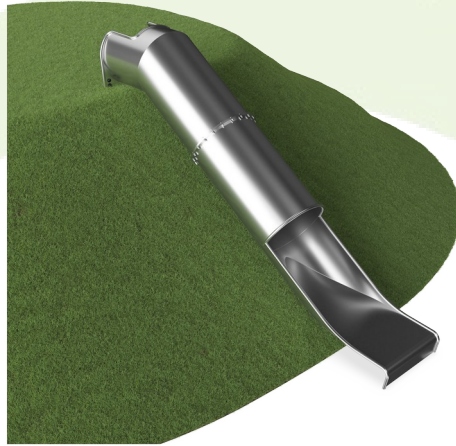

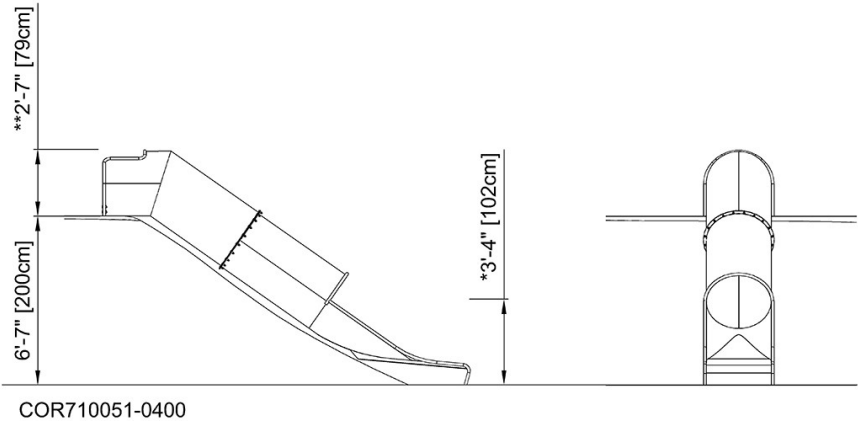
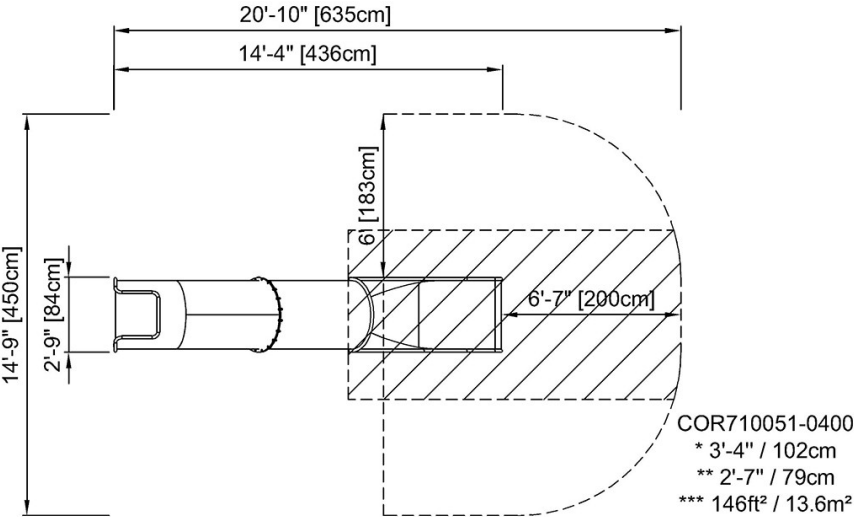
