
Basketball goal

A basketball goal can be used by only one person, two or a whole group simultaneously. Here everyone can join in and it's easy to walk to and from the game. The basketball hoop is placed at the official NBA height of 305 cm, and has the official NBA size of 46 cm in diameter.

The basketball hoop is made from hot dipped galvanized steel with a powder coated finish. The net is made from Ø4 chain links made from \$235 Galvanized steel or stainless-steel chains which meet the requirements in ISO1434-ISO1435 and DIN766. The chains have a circumference of ~Ø30cm at the bottom and ~Ø50cm at the top.



Panels of 19mm EcoCore[™] HDPE. EcoCore[™] is a highly durable, eco friendly material, which is not only recyclable after use, but also consists of material produced from +95% recycled post consumer material from food packing waste.



The steel surfaces are hot dip galvanised inside and outside with lead free zinc. The galvanisation has excellent corrosion resistance in outside environments and requires low maintenance.






